- 4.1 AGENDA PLANNING:
 - o Timeline for School Operational Plan
 - David Musemici reinforced that Star Rating Subgroup is focused on SPED. Resource teachers are
 progress monitoring 1x a month. Incorporating the fundamentals structure into SPED resource classes
 and learning labs. Cannot qualify for SPED in Social Studies, only qualify in math and English
 - Rebecca Owen raised concern over including remediation for reading writing math not for social studies.
 - Discussion occurred over the way special education is implemented at Tarkanian with the result being that remediation in offered in resource classes and in general education science and social studies students are participating to best of ability since there is no direct support in Social Studies and science classes so graded for participation. Deficits being addressed in in resources. The purpose of social studies and science for our special education students is to get experience with a master teacher who is an expert in their content area even though it may be above the students learning ability. In learning lab students will focus on their English and math deficits
 - Andrew Hardin brought up the idea of the goal is to promote growth in the scores
 - David discussed that we are doing what is asked by the district. Assessments are to monitor students progress. There should be some growth and that's where the schools focus is.
 - Andrew asked is there a target growth the school has to meet?
 - David discussed there is a 10% is the target. The tests we are using are equitable for growth data, because students are being compared to students who scored the same as them. If proficient would not have IEP
 - Stephanie Hansen asked How many kids are in the resource?
 - David responded that there are 4-8 kids per learning lab, around 120 IEP students. Some have learning lab some do not, it depends on their need. Academic deficit reading writing math have learning lab. Most of the students benefit from general education and resource room

- Stephanie asked for clarification of how special education looks in Social Studies
- Rebecca Owen explained that there is a learning goal which is Learning Goal → English Goal to get scores up and continue growth. Students with an IEP in Social Studies are Graded for participation, consult with TOR. Accommodations implementation will take place once social studies team is aware of how the standards are changing.
- Discussion took place about when SBAC testing will be. The decision was it is up in the air. They are
 trying to balance giving teachers time to teach content but also balancing student burn out.
- o December 2018 Strategic budget Background Information School Performance Plan
 - Kristy informed the team that know the December meeting would be how to look at the budget. The school budget presented after winter break
 - David informed the group that Title 1 money goes towards prep buyout, which is the best use for the money. As long as Title 1 money continues class sizes will remain reasonable. Concern about burning teachers out
 - Rebecca asked about projected title 1 money
 - David addressed the concern that with the new school opening there could be new zoning that could impact our Title 1 money.
