- 4.1 UPDATES: General School Update

- o Working on creating School Performance Plan – no SBAC data making it difficult – Due Friday 10/ 9
    - Will focus on Math and ELA schoolwide and for SPED
    - AP working on plan and Goals will be set according to distance learning
    - Unsure what will happen with distance learning
      - We do have Map Data but with MAP @ home not sure what data will look like
        - o Proficiency between 40-45% without familiarity with grade level material – students haven't seen it
        - o Looking for growth over the school year
  - o Supporting Teachers with distance Education
    - So that students can be supported and show growth
    - Parent concern: students struggling with getting content and getting work turned in – not a ton of support from teachers
      - How can we make things easier for the kids?
      - Additional teacher training? – is aware we already have a ton on our plates
      - Tolerance around technology use
      - Connectivity issues with IC and Canvas need to be addressed – district is working on it
      - One class nothing is in Canvas from that teacher
    - Student Perspective: Some teachers get held back with tech issues because they are helping other students
    - Teacher Concerns: Grades back and forth
      - Trying to look at Canvas instead of IC
      - Canvas = most accurate
      - QB = Infinite Campus
      - Gradebook Min F – will address in staff meeting
      - Survey Results – Unsure
      - Mask Usage by adults on campus – will address in staff meeting
